I spoke to Alexandra today. She told me she would allow supervised timesharing with Brian and the children once or twice this weekend.

She told me that she stopped responding to him after he came to her home last month to see the kids and pushed his way through the door to try to get to them.

He came to the home unannounced, as well.

Further, he berated Alexandra on Wednesday night at Jeff Rubys. She was on a date and Brian was there, going from table to table. Alexandra states that he sat at the bar and stared at the two of them until her date got up to go to the restroom. At that time, Brian came to the table and berated and cussed at her about the children and the situation. He also denied the things Whitney stated in her petition. Alexandra and her date were the last to leave Jeff Rubys that night and when they walked outside, Brian was sitting in his Mercedes waiting and watching.

This behavior is what is alarming to Alexandra. She states that he is completely "unstable", to use her word. I've told her that supervised timesharing should resume this weekend and she assured me that it would. She also believes Brian should submit to a psychological examination. She states that she believes it more so now than ever, after his behavior this past Wednesday night.
