

Children's Therapy

Questionable Entries

The therapy session notes are not consistent with the children's visits with the father prior to each session. The children are happy and participate in many activities. During therapy sessions the mother is reported as interjecting and conveying the children's supposed neglect and abuse by the father to the therapist. The father is the subject of every session with both children.

Therapy began on April 1st, 2021 and ended in October 2021 (the same time the father was restricted to supervised visitation (1 hour, every other week). The mother did not inform the father of the therapy, the son admits therapy was a secret to be kept from his father in his interview with the judge.

The children had therapy once a week on Thursdays. One child had a session at 3pm, the other followed at 4pm, which went first varied. The father had visitation on Tuesdays and Fridays, with the children staying the night each visit.

This document exposes 3 areas of interest per therapy session:

1. Activities with the father on the Friday and Tuesday visits prior to each therapy session. These include descriptions of the events, as well as photos, videos, and other documentation.
2. An excerpt from each session and comments.
3. Texts between the father and mother AFTER each therapy session and just prior to the next session. The mother never mentions the therapy sessions of either child or raises any concerns regarding the children's negative comments about the father.

Session Notes

Children's session appears to be together. Mother describes Jack as moody and aggressive. The therapist states Jack is constantly moving during the session, talks over his sister when asking questions. Jack states that he likes karate and school. Jackson's support is nuclear family. Adaline's support is nuclear family and extended family. A specific note regarding Adi is not provided.

Session Notes

Children are seen separately. Jack speaks with the therapist first and states it makes him jealous when father treats sister differently and that they play on their own when they visit on that day.

Jack was in school on April 2nd and April 6th. April 3rd dad hosted Easter for the family.
Adi states she likes going to her dads. (Note: Mother was not present at this therapy session, she was out of town.)

Jack stated he was mad and sad. He reports that dad's girlfriend called him a sassy mouth and took his cell phone from him. Dad called him a spoiled 7-year-old and a shithead. This hurt his feelings. Dad always calls him bad names. [Jack did not attend school this day with his mother.](#)

Adi says that Dad was mad at Jack, took his phone and pulled the television in his room off the wall. Dad called him names.

[We believe this is the first session of coaching. Dad has never referenced the children with curse words, yet both make this accusation.](#)

[Why did Adi, a 5-year-old, in session without Jack, comment on the exact same incident that only involved Jack, 2 nights prior?](#)

Session Notes

Jack says that he would like to know if dad is in a good mood or bad mood before he goes to his house. He is afraid of dad when he is in a bad mood. Dad's girlfriend is mean to him and tries to get him in trouble.

Mom tells counselor she knows something was wrong with Adi.

Adi states she is sad and scared. Daddy called her a bitch and has not told her mom.

The visits with dad consisted of an indoor amusement park and trampoline park. Neither child was admonished for bad behavior.

Why are both children stating that, today in particular, they are both scared of dad?

Jack's comment "would like to know if dad is in a good mood or bad mood before he goes to his house" - he repeats this line verbatim in CPS report with his mother on 8/4/21.

Mom informs therapist something is wrong with Adi, and then in sessions the 5-year-old states dad called her a name and hasn't told mom? This could not be more staged.

Despite mom's concern and Adi's accusation her father called her a "bitch" and upset her, the mother makes no mention of this to the father 2 days later, on the 24th, in which they both joined the kids at a party, hosted at a public nerf gun venue, for 2 hours.

Session Notes

Jack says he is sad, happy, and stressed. He states his dog died and his dad laughed at it dying now he will be mean to his other dogs.

We do not understand why Jack would say this about his dad. Mother brought children to meet dad at vet when the dog was put down. His father had the dog for over 12 years and was upset. Dad is also a huge animal lover, has donated to no-kill shelters and taken in rescues.

Adi states, she was happy that day. She mentally creates – good pair of Kings/Queens and an evil pair. She states the evil pair are taking over the world, good pair trying to stop them. Why do parents sleep in the same bed? She states Daddy and Lexi sleep in the same bed. Mommy sleeps by herself.

Adi speaks with the therapist first. She states it makes her sad when daddy calls her the B word when he is mad. She again states that daddies and mommies sleep in the same bed.

Jack enters therapy room with a smile on his face he says his role model and positive person is his mother and describes his father as, "being mean, cussing all the time and not a good person."

Therapist notes that mom and grandma say that they have noticed that Adi has been feeling **neglected** at her father's house she has even articulated this.

Mom and grandmother chose the wrong date to claim neglect - sleepover, surprise trip to Disney on Ice w/new dress, SkyZone, etc. The 2 visits prior to this session were the most eventful we had until our trip to Kings Island in July.

Jack speaks with therapist first. Jack states that last visit with his dad was good he was in a good mood that "he is treated better by his dad and Adi he just ignores her".

Jack's session introduces the dragon fighting the skeleton and a king/sorcerer who controls the dragon.

Adi states her daddy treats her differently and ignores her.

Adi continues with her imaginary thoughts, the King and Queen are good, but the prince and princess are evil and are trying to take over the world and everything is going to be bad.

Jack contradicts his earlier statement regarding his jealousy of how his dad treats his sister.

Adeline speaks with therapist first and states, "Jack almost hit his grandmother and that made her really scared." Adi introduces a daughter of the good King & Queen (previously mentioned princess?) She states that the daughter was buried in the snow. She then states that the evil couple was also buried in the snow and died.

Mother informs therapist that on a visit with his dad that Jack told her via text/call that he wanted to spend more time with his dad. When he returned to his mother's he denied wanting to spend more time with his dad and just "went along with his dad".

Jack discusses dragon fighting skeletons.

(Dad was not around when Jack sent the initial text). See texts

Jack speaks first to therapists, ok visit with dad - states his girlfriend wasn't at dad's the first visit.

Jack states on the Tuesday visit his dad and Lexi had a fight/yelling, and that Lexi locked him out of the bedroom and Dad slept on the hallway floor. ([Text messages prove Jack slept in master bedroom](#))

Adi tells the therapist she gets scared when daddy yells, calls her and Jack names. Dad calls her Bitch and Jack a MF'er and bastard.

Jack's session is first. He states the past weekend was not too bad, played with cousins, Dad did not get angry because cousins were there. Jack identifies as the dragon attacking skeleton men.

Adaline speaks of denying food to a toy lion.

Mom reports Adi came home in tears claiming dad and Lexi held her underwater to teach her how to swim.

Adi states she can jump off the diving board and that she can go underwater.

Jack was worried about his sister while swimming because of dad & girlfriend. Accused Lexi of pulling him underwater by his legs.

Adi and Jack went to the pool with Lexi and her friend Juliet, dad did NOT go to the pool that day.

Mother claims dad and girlfriend held Adi underwater - Adi would know that same day daddy was not at the pool...

Adi did not mention being held underwater.

Jack repeats mother's claim of dad and girlfriend being at the pool harming Adi.

Mom never mentions to dad any issues with swimming and in fact discussed details of Dad taking the children to 2 water parks in Ohio in upcoming weeks via text.

Session Notes

Jack tells the therapist he had a good time at Kings Island and Great Wolf Lodge. He says his dad slapped him across the face over the shoes ... he also discusses his nice barber, Josh.

Adi says she had a good time with daddy, Lexi and Jack at Kings Island.

Jack discussed his trip to amusement parks with dad.

Jack accused dad of slapping him because his shoes were too tight and mentions the nice barber Josh, just as he did in the interview with the judge, as if to immediately change the subject.

Adi did not mention Jack being slapped.

August 6th dad went to Adi's gymnastics to pick up kids and the mother informed him that he couldn't have the kids and that the police were looking for him.

August 12th

Jack states he is going to talk to the judge in 2 weeks about how daddy is treating them.

He spends the entire time destroying a house with skeleton inside.

He states that the skeleton of the house was the original owner of the dragon. And when the skeleton died the dragon turned evil. And that is when the wizard took over him and used him for his evil plans.

Adi had fun at her first time at school.

Adi states she will feed the lion, but he has to pay all his money to her, not her rules but her boss' rules.

Jack knows he will be talking to a judge 2 weeks in advance, how does he know this?

Jack mentions talking to the judge, then fantasizes that skeleton died, dragon turned evil, and wizard took over him and used him for evil plans. Could dad be the skeleton? Jack has already claimed he was the dragon.

Is the skeleton dead because dad was restricted by EPO from seeing the children just days prior?

Is the wizard's use of the dragon for evil plans equate to mom forcing Jack to lie about dad?

Is dad the lion in Adi's session? Mom often told tells kids dad doesn't give her enough money. Who is Adi's boss? Mom?

August 19th

Jack has not talked to the judge yet, mom is in CA, he has seen dad at grandparents and dad was nice. Says grandparents don't like him" because how he treats them".

Adi likes school and friends. Adi is happy to not to go to dads and likes seeing him at grandparents.

Adi lets the Lion eat. Therapist notes this is the first time she lets the lion eat.

Jack doesn't think grandparents like him? (Parental alienation issue?)

Both kids like seeing dad at grandparents instead of his house. Repeated wording and pushing supervised visitation over being at dads.

Kids see dad for first time in 2 weeks, is this why Adi lets the lion eat?

September 2nd

Jack talked to the judge and explained what happened. He is sad and his family is changing, he's ok.

Adi says her family is changing, she is sad, but it's ok. She doesn't miss dad being mean to her and her brother.

Children repeat phrase verbatim: "family is changing, sad, but it's ok."

September 9th

Jack said the day he spoke to the judge that dad spoke to him to say he loved him, and dad wasn't to do that, but Jack wasn't surprised dad does things he isn't supposed to all the time.
(Said same phrase to the judge in video interview)

Adi again states again her family is changing and that she hasn't seen her dad since going to court for her daddy hitting her brother. Draws pic of her family to only include her, Jack, Ali and Jan.

Adi was not at court that day and did not see her dad.

1st time Adi mentions dad hitting Jack.

Adi was quoted in police report on 8/6 that dad had never hit either of them.

September 16th

Mom reports Jack has been experiencing bad dreams, Jack denies.

Jack states he misses his dad but glad he doesn't have to be scared when he goes to see him.

Adi > Lion > Candyland (dads) > King & Queen, Prince & Princess figures - she buries the bad figures, and the good figures walk away out of the box.

October 7th

Mom reports both children were very nervous when told they were going to see their dad.

Adi talks of seeing daddy with someone in the room and he is nicer to them, only one hour but it is good.

Jack said he was scared when he was going to see his father. He states, I guess it will be ok. Especially when he found out he would be visiting with someone there. Dad was nice.

Mom reports both kids were nervous. Jack says he was scared.

Jack said someone in the room, Adi said with someone there.

Jack said dad was nice, Adi said dad was nice.

October 14th

Adi says she is good, hasn't seen dad. Is ok with not knowing when she will see dad again.

Jack states he doesn't relax and doesn't sleep - his mom contradicts, he sees Pennywise when closes his eyes.

Discussed discharge and medication for sleep.

October 21st

Adi draws a picture of her favorite things - her mom, her, and her house.

Says her father told her they would be coming back to his house sometime. Mom told her that was "Inappropriate and would talk to Greenhouse".

When asked if she was ok with going back to her dad's house, she guesses it will be ok.
She doesn't like being called bad names or when dad is mean to Jack.

She makes a circular train track but would not connect it, several times she had a connecting piece in her hand but would lay it to the side.

No notes for Jack.

Adi told dad she's never coming back to his house:

Dad's comment "you will be coming back to my house eventually" was in response to her asking "Why would you buy that (furniture piece for her bedroom) if I'm never going back to your house?"

Why would she assume she is never coming back to my house? Adi is 5 and doesn't use the word "inappropriate".
